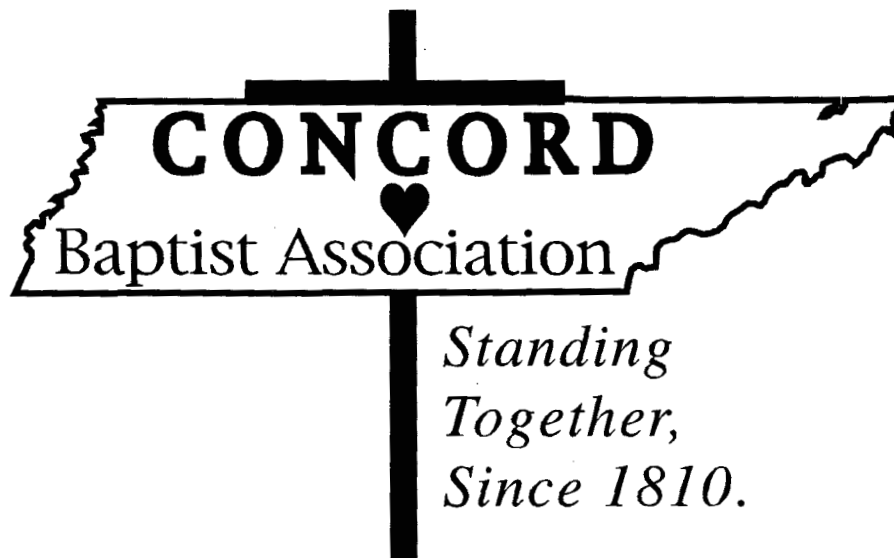

# CONSTITUTION

## Preamble

The name of this body shall be Concord Baptist Association. It is composed of cooperating Southern Baptist Churches whose confession of faith affirms the Word of God as its guide for faith and practice, and supports the principles, beliefs, and programs of the Concord Baptist Association, the Tennessee Baptist Convention, and the Southern Baptist Convention.

## Article I – Purpose

The purpose of this association shall be:

1. To foster fellowship among the churches cooperating with this association.
2. To assist the churches in strengthening their ministries of enlistment, evangelism, teaching, and training.
3. To encourage the churches in the promotion of missions and the establishment of new churches.
4. To promote those ministries of the Tennessee Baptist Convention and the Southern Baptist Convention as it may deem proper.
5. To promote the Mission Statement, Vision Statement and Core Values of the association.

## Article II – Membership

A church may be a member of Concord Baptist Association upon fulfilling the following criteria:

1. A church shall affirm the Word of God as its guide for faith and practice, and support the principles, beliefs, and ministries of the Concord Baptist Association, the Tennessee Baptist Convention, and the Southern Baptist Convention.
2. A church shall petition the association through the Administrative Leadership Team.
3. The association reserves the right to withdraw membership from a member church or withhold membership from a petitioning church which does not affirm the Word of God as its guide for faith and practice, and does not support the principles, beliefs, and ministries of the Concord Baptist Association, the Tennessee Baptist Convention and the Southern Baptist Convention.

## Article III – Seating Messengers

1. Each church shall be entitled to five messengers. Each church shall be entitled to one additional messenger for each 50 members over 100 until a maximum of 10 is reached. Said representatives shall be messengers to the association upon credentialing at the Annual Meeting.
2. A two-thirds (2/3) majority shall be necessary to refuse to seat messengers from a member church.
3. A two-thirds (2/3) majority shall be necessary to seat messengers from a new church.

## Article IV – Visitors

Visitors may be invited to be seated in the body with all privileges except that of voting or speaking to a motion in regular business session.

## Article V – Officers

1. The regular officers to be elected by the association shall be moderator, vice moderator, clerk, assistant clerk, treasurer, and assistant treasurer.
  - a. The moderator and vice moderator shall be nominated from the floor.
  - b. All others officers shall be nominated by the Administrative Leadership Team.
  - c. No one shall serve as moderator for more than two (2) consecutive years.
2. The duties of the moderator shall be to preside over all meetings of the association, put all proper motions to the body, appoint committees not otherwise provided for and see that a suitable decorum is preserved in the meetings. The moderator shall also serve as chairman of the executive committee. The moderator shall be an

ex-officio member of all committees/teams.

3. The duties of the vice moderator shall be to perform the functions of the moderator in his absence and to assist in any other ways that the moderator or association may desire. The vice moderator shall be an ex-officio member of all committees/teams.
4. The duties of the clerk shall be to keep correct records of the proceedings of the annual associational meetings and the executive committee meetings together with a list of the messengers composing them and publishing them in due form and time.
5. The treasurer shall make authorized disbursements of all associational funds. The treasurer shall make a monthly report to the executive committee and an annual report to the association showing all receipts and disbursements.

## **Article VI – Authority**

The association recognizes the autonomy of the local churches and shall exercise no authority over them. It shall nevertheless, be the duty of the association to offer fraternal counsel to any church upon request of said church. (Matthew 18: 15-17)

## **Article VII – Annual Meeting**

1. The association shall hold an annual meeting at such time as the association may indicate.
2. A quorum shall be the messengers representing at least 50 percent of the cooperating Baptist churches.

## **Article VIII – Executive Committee**

1. The association shall have an executive committee composed of the moderator, vice moderator and clerk of the association as its officers. One member and the pastor from each member church shall be members on the executive committee. For every 100 members or fraction thereof a church may appoint 1 (one) additional member up to a total of ten (10) executive committee members.
2. The executive committee shall transact the business of the association between annual sessions or any other business committed to it by the association in annual session.
3. A quorum will consist of those members present at the meeting.
4. It shall include meetings – the third Monday of February, May, and August.
5. The moderator in consultation with the Director of Missions, the vice moderator and the associational clerk shall be authorized to call the executive committee into special sessions.
6. A minimum of two weeks notice is required for a called Executive Committee Meeting.

## **Article IX – Revision**

Any article of this constitution may be revised by said article being presented in printed form one year before the association is to vote. Any revision must be approved by a two-thirds (2/3) majority.

## **Article X – Procedures**

1. The moderator elected at the previous meeting of the association shall give the executive committee report at the opening session, reviewing the work of the past year.
2. This Constitution and By-Laws and Robert's Rules of Order shall be the standard of authority in parliamentary rulings.

## **BY-LAWS**

1. Each meeting of the association shall be opened and closed with prayer.
2. Only one person shall speak at a time, who shall rise and address the moderator; and while speaking, he shall confine himself strictly to the subject in question and shall not be interrupted unless he digresses from the subject, and in no wise reflects on any other speaker, to give fairly his own views of the cause without undue

criticism. No member shall address another in any unchristian manner.

3. The moderator shall be entitled to the same privileges as any other member provided he vacates “the chair” but shall have no vote except in the case of a tie.
4. The names of the messengers shall be published in the Minutes as they have registered at the associational meeting.
5. The associational year shall be September 1 through August 31.
6. The associational fiscal year shall be January 1 – December 31.
7. By-Laws shall be revised by majority vote of the Executive Committee.
8. Associational Committees and their Duties.

Membership on all standing committees shall be on a rotation basis unless otherwise indicated, with one-third (1/3) elected annually for a three year term. No person shall succeed himself until one year has elapsed. Membership on all elected committees shall be distributed as far as possible among lay people and staff members of local churches.

The following committees shall serve the association and shall report to the bodies indicated. The composition and duties of these committees shall be as follows:

A. Personnel Committee

This committee shall be composed of three members. The committee shall screen all of those nominated to them by the appropriate committee for employment by the association. The committee shall call or recommend the employment or dismissal of employed personnel to the Executive Committee or the association in Annual Session.

B. Finance Committee

This committee shall be composed of six (6) members: The treasurer and financial secretary shall be ex-officio members. This committee shall:

1. Recommend procedures and plans for all money matters connected with work in the Concord Association and report to the Executive Committee on matters related to the financial status of the association.
2. The committee shall prepare the budget for the association’s consideration and approval. The proposed budget will be mailed to the Executive Committee members prior to the Annual Meeting at which time the budget will be voted on by the Executive Committee and forwarded to the association for final approval.
3. Promote a program of stewardship education and clinics on church finance.
4. Encourage churches to contribute and to increase contributions to the cooperative Program and associational missions through their church budgets.

9. Associational Teams and their Duties.

Team members will be recruited or accepted to work on specific tasks and move toward performance groups. Teams may have defined membership who may serve indefinite terms based on task completion. The team leaders will be chosen by the Administrative Leadership Team. Members will be approved by the Administrative Leadership Team for a specific team. The number of members per team may vary as determined by the Administrative Leadership Team. Team leaders will be elected at an Executive Board or the Annual Meeting. Team Leaders will serve only one team at a time. Team members, by definition are persons who have expertise, gifts, skills and preferences to complete a certain task or mission.

A. Mission and Ministry Team Shall:

- (1) Develop and implement the mission and ministry plans of the association.
- (2) Train, develop and encourage church and associational workers.
- (3) Provide opportunities for working together in missions and ministry.
- (4) Report to Executive Committee as necessary.

B. Church Support Team Shall:

- (1) Develop and implement support to ministries within the churches.
- (2) Coordinate training events for ministries inside the churches.
- (3) Encourage fellowship groups
- (4) Offer consultation and support to church staff with responsibilities in area of church programs.

C. Evangelism Team Shall:

- (1) Develop and implement evangelism strategies for the association.
- (2) Coordinate training events to encourage evangelism efforts in local churches.
- (3) Offer consultation and support to local church staff in the area of evangelism.

D. Administrative Leadership Team Shall;

- (1) Serve as a coordinating team for the total mission of the association.
- (2) Be empowered to act for and on behalf of the Executive Board between meetings of the board.
- (3) Create, adjust and dissolve teams as needed to accomplish the mission of the association.
- (4) Review proposals and make recommendations to the Executive Board concerning the constitution.

## **TRUSTEES**

1. The association shall elect three trustees, each to serve three years, with their terms to rotate that the term of one will expire each year. The chair shall be selected by the Administrative Leadership Team.
2. Any vacancy occurring between Annual Meetings shall be filled by the Executive Committee upon recommendation of the Administrative Leadership Team.
3. The trustees shall be the legal representatives of the association and shall act for the association upon orders of the Executive Committee. Their responsibility involves all legal matters, protecting the interests of the association where any process of law is required.

We believe in cooperation with other churches in the association, practicing obedient stewardship of our resources, in order to accomplish the mission purpose of the association.

1. Milton Hicks, moderator called to order the 198<sup>th</sup> annual meeting of Concord Baptist Association at 4:00 p.m. on October 20, 2008 at First Baptist Church, LaVergne.
2. Max Burnette led the association in a hymn.
3. Bill Thomason, pastor of FBC LaVergne gave the welcome, scripture and prayer.
4. The moderator called for a motion to seat both the messengers present and those to come. Motion made, seconded and carried.
5. Our moderator recognized our visitors.
6. Kim Margrave brought greetings from the Tennessee Baptist Convention.
7. Milton Hicks delivered the moderator's address. He used scripture from I Samuel.
8. The reports were adopted as printed.
9. Michael Smith, committee chairman, presented the proposed 2009 budget from the Finance Committee. A time was allowed for discussion.
10. Max Burnett led the committee in a hymn.
11. Special music was proved by Vanessa Harriman.

17. Tim Fisher, Kingdom Growth Coordinator, introduced the following new pastors and staff members present: Eric Hinson, pastor of Cannon Community Church, Joe Carpenter, staff member from Eagleville, Phil Potratz, staff member from FBC Murfreesboro and Ron Wilcoxson, pastor of Bent Creek Church.
18. Michael Smith, committee chairman of the Finance Committee presented a recommendation to approve the proposed 2009 Budget for the association. Recommendation approved.
19. During the time for miscellaneous business Tony Long presented the Administrative Team recommendation for approval. The recommendation was approved.
20. Amber Vaden spoke to the BCM Report.
21. Fred Rolater spoke about the history of the association that he is in the process of writing.
22. J. David Pittman, Director of Missions, gave his report.
23. Max Burnette led the committee in a hymn.
24. Special music was provided by the group "Whosoever".
25. Chris Brewer, pastor of Rock Springs, brought the message. He used scripture from Joshua.
26. The 198<sup>th</sup> annual session was dismissed with prayer led by Lenny Farmer.

## Executive Committee Report

Our annual meeting was held on October 15, 2007 at the Calvary Baptist Church of Murfreesboro. This wonderful Church did a great job of hosting the meeting and providing a delicious meal. The Pastor, Brother Mark Gregory, welcomed us warmly, and shared an inspiring devotional.

Our first meeting of the year was a called session at the Belle Aire Baptist Church on November 26, 2007. The host Pastor welcomed us and shared a time of devotional. Five motions concerning the future building were made and passed unanimously. The first motion was to purchase the property on Perimeter Place South. The second motion was to approve Huddleston Steele to prepare the plans for the site and building. The third motion was to retain the services of Michael Stewart as architect. The fourth motion was to hire Donald Corley as the contractor. The fifth motion was to retain Mark S. Moore to prepare the contract, to review the contract with the contractor, and to oversee the construction of said building.

Our second meeting was held with the Scenic Drive Baptist Church on February 18, 2008. The meeting began with a welcome, Scripture reading, and prayer from the Pastor, Brother Ron Hardeman. Reports were heard from the Strategy Planning Committee on the new building. Brother Gary Rickman from the Tennessee Baptist Convention shared with us concerning the Ten x Ten Campaign. This campaign will seek to enhance Stewardship and Cooperative Program giving in the Association. Each Church is encouraged to give 10% of all undesignated offerings to the Cooperative Program by 2010.

The next meeting was held at Green Hill Baptist Church on May 19. Brother Ron Byers, moderated the meeting in the absence of

the moderator. Brother Leonard Rader led the meeting in a welcome and devotional. Reports were heard and the Strategy Planning Committee presented the proposed floor plan for the new building. The meeting was closed by singing a song that was written by Brother Harry Nichols.

Our August 18 meeting was held at the Crossway Baptist Church. Brother Randall Davis, the Director of Education of the Church led us in devotional and prayer. Several reports were heard, including one from our Missions Coordinator, Brother John Seals. There was no old or new business. The meeting was closed with a time of prayer.

Exciting days are ahead! Hopefully it will not be long until construction is underway for the new building and Concord Baptist Association will have a permanent home. Thanks to all who have faithfully attended the Executive Committee meetings.

## **Director of Missions Report**

This has been a good year in the life of the Concord Baptist Association. Our work is healthy and strong with many signs pointing toward this being a great year in our history. We are in a time of transition into our new structure and into our new building. These changes bring new challenges but we seem to be progressing in a positive way. We, like most Southern Baptist organizations, are experiencing a tight budget but this is normal for what is taking place in our national economy.

Our plan to construct a new office building of around 3650 square feet continues on schedule. The location of this project is 2633 Merchants Walk in Murfreesboro. We would all like to see this process hasten along but we are told that this timetable is to be expected. We will keep you informed with the progress. The architect, W. Michael Stewart, has delivered our final plans and we have forwarded them to Donald Corley, our General Contractor, who is making preparation to begin this project. We are planning a ground breaking ceremony in the not too distant future.

In the near future the Strategy Planning Committee will begin working on coming up with guidelines for use of the Mission/Ministry Fund. As you recall, this fund will consist of the money remaining from the sale of our Church Street property after the new building is completed. These funds will be placed in an interest bearing account with these earnings to be distributed to our churches for projects of their choosing. At this point we do not know the amount of money that this will be. However, we believe that agreeing on guidelines to be used in their distribution is appropriate.

Plans are currently underway to celebrate the Concord Baptist Associations two-hundred years of ministry in Middle Tennessee. We will reach this monumental milestone in the year 2010. Our moderator will appoint a committee to oversee every aspect of our celebration. Part of this occasion will be the publication of our history from 1810 – 2010. Dr. Fred Rolater is working on a manuscript for this book at the present time with plans for completion prior to next year's annual meeting. Churches will be asked to provide a short history of their congregation along with a picture to be incorporated in this publication.

The Concord Baptist Association is blessed with an excellent staff. It is a pleasure to work with them in the work that God has called us to. During my convalescence last year they did a yeoman's job in making sure that the work of the association continued on. I am grateful for each one of them and want to express my appreciation for their tireless effort.

My health continues to improve. I have returned to normal office hours and am available to our churches as needed. I appreciate the prayers that have been lifted for me and my family. My belief is that God chose to answer these prayers because there is still more work that He has for us to accomplish together. Let's each do our part to make this year of transition one of the most exciting and rewarding times in the two hundred year history of the Concord Baptist Association.

### 2007-2008 School Year - Weekly ministries

- International Student Ministry- Tuesdays, 6:00 p.m. This is a weekly supper for Internationals and American students to get together and practice conversational English. This allows us to begin relationships and open doors to further share about Christianity.
- Noonday - Wednesdays, 11:30 p.m. Noonday provides an excellent outreach to the campus with a home cooked meal and a devotion.
- Manna - Thursdays, 7:00 p.m. Manna is a collegiate Bible study and worship led by a student band.

### Ministry Highlights

- Approximately 120 MTSU students were regularly involved in one or more BCM ministries this year.
- Welcome Week kicked off our Fall Semester with a Welcome Back Cookout, Pancake Drop In, and front

lawn Block Party, Noonday, and a tailgate at the first home football game. Over 125 new freshmen and transfer students turned out for these events. Throughout August, September, and October, new students outnumbered our returning students at almost all of our events.

- Noonday went outdoors! This fall we moved our Noonday ministry outdoors twice, meeting and serving over 100 students at each one. Our students led out in the set up, serving, and providing live music on the lawn.
- Intramurals gains momentum! This year we strongly cast the vision for our intramural sports teams to be used as an outreach tool.
